"We need to keep our promise to women and children who are victims or survivors of any form of violence against women, to end that violence. Globally, nationally, locally we must take responsibility, each and every one us, and commit to speaking out against violence and changing attitudes and behaviour that allow it to continue unabated. AWAVA will be joining hundreds of preventing violence against women sector organisations from across the globe at this year's United Nations Commission for the Status of Women in New York. The 57th session is focussing on the *Elimination and prevention of all forms of violence against women and girls*. AWAVA's focus will be on helping to negotiate outcomes that can make a real difference in ending violence against women. AWAVA has a delegation of experts from across the violence against women sector that will be sharing knowledge, good practice, resources and expertise from Australia and learning from other countries.

Julie Oberin says: "AWAVA will be partnering with international organisations to discuss the power of the feminist movement and to encourage the preventing violence against women sector to 'think big' and demand what women and children deserve - a convention to end violence against women and girls."

Back in Australia, AWAVA will be joining forces with the Twittersphere to push to get #endvaw trending on Twitter on International Women's Day, Friday 8 March.

"If we're to succeed in ending violence against women, we need to be able to talk about it, to challenge attitudes that condone violence and to work out how we address gender and other social inequalities that allow violence against women to continue.
