In the 1980s Australia was admired, internationally, for its government sponsored feminist leadership. In the early 90s every Australian education department had a gender equity unit and there was active and explicitly feminist development and implementation of gender equity policy. The imperative was clear, and support was available, for educators to address the limiting gendered beliefs, attitudes and behaviours of young people.

Although gender issues remain salient, over the past 30 years feminist participation in the development of policies and programs in education has been increasingly silenced and marginalised.
